Stutt lýsing á verkefni (hámark 255 slög): The project is meant to enrich the local experience of Reykjavík for its inhabitants by developing a map of the city's places of interest (historical, community, artistic), that will combine the city perspective with the individual perspective.

Markmið verkefnisins (hámark 1100 slög): The main goal of the project is to create new ways of looking at and experiencing the city of Reykjavík. The project will center around developing new features on the community platform totel.ly, to provide digital modalities to explore Reykjavík city and allow users to interact with specific places of interest.

Lýsing á verkefni (hámark 1650 slög): The totel.ly platform is a digital tool meant to support real-life connections and to build local and hyperlocal communities. Its themes are threefold: self-development, community-development, and regenerative practices. Currently, people can register to the platform, list their needs and the resources or services that they are willing to offer, and they can connect to each other to make exchanges. Closed groups can be created around common interests. The platform will be developed to include a gamification tool, that supports experiential learning in the three areas. Through this project, the platform would also gain a map feature that allows to discover places of interest in Reykjavík. Research will be done to identify a minimum of 10 places of interest from the city. Totelly has an established partnership with the Communications and Innovation department of Reykjavík City Library, within the Civic Participation team.
