Fundurinn er haldinn af Efnahags- og félagsmálaráði Sameinuðu þjóðanna fyrir Evrópu (UNECE) í samstarfi við Global Cities Hub. Fundurinn er hluti af stærri fundaröð sem hefur það að markmiði að efla rödd borga og þéttbýlissvæða í alþjóðlegu samhengi og sýna hvernig borgarstjórnir geta lagt sitt af mörkum til heimsmarkmiða Sameinuðu þjóðanna og lausna á brýnum áskorunum. Yfirskrift fundarins er *Cities Shaping the Future* og þar hittast tugir borgarstjóra til að skiptast á reynslu og hugmyndum, kynna nýsköpun í borgarþróun og ræða leiðir til að bregðast við sameiginlegum áskorunum. Borgarstjóri mun jafnframt flytja ávarp á hliðarviðburðinum *Woman and Mayor*, þar sem rætt verður um leiðtogahlutverk kvenna í borgarstjórnum og mikilvægi jafnréttis í stjórnsýslu og ákvarðanatöku.

Invitation to the United Nations Forum of Mayors' meeting "Cities Shaping the Future" (Geneva, 6-7 October 2025)

Dear Mayor,

We have the pleasure to invite you to participate in the fifth meeting of the UN Forum of Mayors, "Cities shaping the Future", to be held in Geneva, on 6–7 October 2025, under the auspices of the United Nations Economic Commission for Europe (UNECE). The meeting is organized in cooperation with other UN Regional Commissions and with the support of United Cities and Local Governments and the Global Cities Hub.

The Forum of Mayors is a United Nations body of a unique nature that enables mayors to directly engage in UN deliberations, ensuring that local governments have a strong voice in shaping international policies, including by making recommendations to member States. The Forum also offers opportunities to exchange good practices and lessons learned with mayors from around the world.

You are invited to the UN Forum of Mayors' meeting following an official selection process: The Forum's Bureau decides on the mayors to be invited, based on countries' nominations of cities or, if there are no nominations, suggestions from the secretariat.

Detailed information on the meeting, its side events and the modalities of your participation are provided in annex to this letter. Please note that, during the plenary sessions, mayors will be invited to address specific sustainable development goals (health, gender equality, decent work); climate funding mechanisms; and housing related challenges. Mayors will also have the opportunity to discuss and report on their cities' Voluntary Local Reviews, if any. Further, the Forum will be expected to elect its next Bureau for the period 2025–2026.

#### Annex

### Information on the UN Forum of Mayors, the upcoming meeting and expected interventions

The **UN Forum of Mayors** is a United Nations body that enhances coherence and complementarity between the local, regional and global levels in addressing common challenges related to sustainable urban development and governance, contributing to the achievement of Sustainable Development Goals. Since 2020, the Forum's annual meetings have facilitated collaboration and the exchange of good practices among mayors and fostered dialogue among cities, member States and relevant international organizations. More than 160 cities<sup>1</sup> have thus far participated in its meetings (see: <a href="https://land.unece.org/forumofmayors/">https://land.unece.org/forumofmayors/</a>).

The Forum is currently at its fifth edition. The meeting will extend over four plenary sessions of 3 hours each (10.00–13.00 and 15.00–18.00). During each of these sessions, you will have the opportunity to address the audience and provide insights into your city's experience, good practices/success stories and strategic solutions (existing or planned actions, policies, strategies, projects, collaborative efforts, innovative approaches), as well as share any lessons learned or recommendations with respect to any of the issues on the agenda.

The meeting programme will cover the following **topics**:

- In alignment with the 2025 session of the High-level Political Forum on Sustainable Development (New York, 14–23 July 2025), mayors will be first invited to address some of the themes under in-depth review at the global level that are of key relevance also to the local governments, namely:
  - o Good health and well-being (SDG 3)
  - o Gender equality (SDG 5)
  - Decent work and economic growth (SDG 8).
- Mayors are then expected to discuss climate finance mechanisms which are essential
  to cover the substantial funding cities and municipalities need for tackling the multiple
  climate change-related challenges that they are at the forefront to confront.
- Next, given the critical importance of accelerating the SDG localization to achieve the 2030 Agenda, a session will be dedicated to Voluntary Local Reviews (VLRs) as key tools for the local governments to monitor and to report on their progress in implementing SDGs. Mayors will be invited to report on their cities' VLRs. They may wish to highlight their approaches for: integrating the SDG implementation into urban planning and for aligning the VLRs with national and regional plans and voluntary reviews, fostering multilevel governance and stakeholder consultations.
- The last thematic discussion will focus on **housing-related challenges** faced by local authorities as regards affordability and sustainability. Mayors will have the possibility

to present their related experience and good practice solutions as well as to agree on recommendations to be transmitted to the ministerial meeting on housing of 8 October.

Towards the end of the meeting, as an outcome, the Forum of Mayors is expected to collaboratively finalize and agree on a **set of recommendations** covering each of the substantive themes discussed. The mayors will receive for their consideration draft recommendations prepared ahead of the meeting by the Bureau of the Forum, with support from the secretariat, in consultation with the mayors' offices of the participating cities. In June-July, the secretariat will convene online consultations on the draft outcome document to facilitate consensus on the document. During the meeting in October, all participating mayors will have the opportunity to further contribute to and refine the document prior to its adoption.

Mayors are encouraged to actively participate throughout the meeting by requesting for the floor on any of the topics they would wish to intervene (by raising their city's nameplate placed before them). The Chairperson will give them the opportunity to speak. A mayor may choose to intervene either from his/her seat or from behind a lectern by the podium. To ensure that all participating mayors have the chance to speak, each intervention should be concise, not exceeding 2 minutes, and be directly related to the topics discussed, covering the key aspects outlined above. This approach will enable efficient and inclusive dialogue among all participants. Interventions can be delivered in one of the official languages of UNECE, namely English, French, or Russian. (Simultaneous interpretation in two other UN languages, Arabic and Spanish, will be subject to the availability of extrabudgetary donor funding.)

To ensure that your contributions are accurately reflected by the interpreters and recorded in the summary of the event, your office is kindly invited to provide the secretariat with 1-2 bullet point(s) per intervention highlighting your most important points and take-aways.

#### Elections of the Chair and Vice-Chairs of the Forum and their role

Before the closing of the meeting, on 7 October, the Forum of Mayors is expected to elect a Chairperson and two Vice-Chairpersons for its next meeting (preliminarily scheduled for 12–13 October 2026), who will hold office until the end of that meeting and provide guidance to the secretariat for its preparation. Should you be interested to serve as a Chair or Vice-Chair of the Forum of Mayors, kindly indicate this clearly in your reply to the secretariat.

The Bureau of the Forum of Mayors holds brief (1 hour) online meetings to prepare for the Forum's meetings. A Chair or a Vice-Chair is expected to participate in about 2 to 3 of them per year as a maximum, when issues necessitating the presence of a mayor would be on the agenda. For the participation in the remaining Bureau meetings and communication on the preparatory work, the elected mayors are invited to nominate a representative from their office and communicate his/her name and contact details to the secretariat at the earliest convenience.

A series of events will be organized in the margins of the 5<sup>th</sup> meeting of the Forum of Mayors, offering additional opportunities for engagement and networking. A preliminary list of these events and their tentative timing include:

1. A side event on urban peace, "Cities of Reconciliation" (6 October 2025, 8.30-9.45)

- 2. A side event on **women mayors** (6 October 2025, 13.15–14.45).
- 3. A **cocktail reception** offered for all mayors and participants of the Forum by the City of Glasgow (6 October 2025, as of 18:00)
- 4. A side event on **environmental challenges for cities** (7 October 2025, 8.30-9.45) (tbc)
- 5. A high-level meeting between mayors and Heads of international organizations, scheduled (7 October, 13.15–14.45)
- 6. A side event on localization of the **SDGs** and **Voluntary Local Reviews**, (7 October 2025, as of 18.00).
- 7. The World Economic Forum will invite participating mayors to its headquarters to discuss 'mission-oriented public-private-partnership to promote innovation at the local level' (8 October 2025, afternoon).
